#### **Nevada Construction Defect Litigation** Still on the Rise

A message from Nicholas Salerno

As the managing partner of the Lincoln Gustafson and Cercos Las Vegas office, I have seen many changes over the past 10 years. Housing prices have soared fueled by a rapidly growing population. Construction defect litigation has matched the housing growth with many California based firms establishing Nevada offices. Residential construction has slowed recently, but construction defect litigation marches on. I have spoken to numerous insurance and governmental groups about the ever increasing expense of construction defect litigation and there is a consensus that Chapter 40 (a law enacted by the Nevada legislature to govern disputes between homeowners and contractors) has not achieved its asserted goal of keeping disputes out of litigation. Despite the best efforts of the construction and insurance industry, it remains difficult to resolve cases without protracted and expensive litigation. Judicial interpretations of Chapter 40 often increase contractor exposure rather than decrease it such that the risks and expense of lengthy litigation are borne primarily by the contractors.

At LG&C, we face the challenges of construction defect litigation head-on. We begin by exploring early resolution, by offering repairs where appropriate, and by seriously participating in pre-litigation mediation. Where the matter moves to litigation, we perform an early cost benefit analysis to formulate an appropriate defense strategy and then assemble the appropriate team of experienced professionals and aggressively defend the allegations while keeping our clients apprised of the risks and rewards of each step so that in the end, our clients can obtain the best result possible. # Court Finds in Favor of LGC's Client in Motion to Compel Arbitration

On January 25, 2008, Paul James, an associate in our San Diego office, and Teresa Beck, Partner, won a motion to compel arbitration in a sexual harassment case. This means an arbitrator, not a jury, will adjudicate the matter, which typically diminishes a plaintiff's expectations.

#### **Labor Board Victory**

On March 4, 2008, Adrienne Johns, another associate in San Diego, obtained a defense award in a Labor Board matter in which LGC represented the employer against claims of overtime, failure to allow meal breaks, and other related issues.

#### **Employment Law Updates**

On January 28, 2008, an expansion of the Family and Medical Leave Act (FMLA) became law. Employers with 50 or more employees are now required to provide 12 weeks of leave due to a "qualifying exigency" arising out of active military duty, or notice of an impending call or order to active duty, of an employee's spouse, parent, or child. Employers must also provide up to 26 weeks in a 12-month period to an employee who is the spouse, parent, child, or next of kin of an injured service member. This measure reflects a growing trend to extend leave benefits to military personnel and their families.

On January 29, 2008, the U.S. House of Representatives Education and Labor Committee held a hearing on the ADA Restoration Act, a bill that would expand the definition of "disability" under the Americans with Disabilities Act (ADA). The ADA defines "disability" as "a physical or mental impairment that substantially limits one or more of the major life activities of such individual." The new bill would redefine "disability" as simply "a mental or physical impairment" and mav require employers to accommodate people with various minor or temporary impairments. Although California employers already operate under a very liberal system allowing for a very broad definition of disability, such action by Congress signals similar changes may be on the horizon across the country. LGC will keep you informed regarding new developments pertaining to this bill.

## A Goal Not a Burden: The Art of Negotiating Ethically

(The following are excerpts of an article published in the 4th quarter 2007 issue of Verdict Magazine.)

For a lawyer, the art of effective negotiating is one of the most important services that can be offered to a client. It is an attribute, however, that clients often do not appreciate or even seek out in a lawyer; choosing, instead, someone who is "fearless and fearsome; ready for battle". This popular misconception of the need for a warrior lawyer is based in part on the misconception that most cases go to trial. The fact is that very few cases go to trial, not because of some dispositive motion but, rather, because they are resolved.

Some may argue that the warrior lawyer persona actually enhances the potential for resolution but there is at least as strong an argument that these characteristics can, at a minimum, prolong litigation and, perhaps, even exacerbate the dispute, resulting in a more costly litigation, longer litigation, and even a trial.

There seems to be an emerging trend to separate lawyers into negotiators and trial attorneys. This trend toward specialization is similar to the starter, middle relief and closer in baseball. It may be based upon the concern that the so called trial attorney may be conflicted in some way and inclined to negotiate out of a trial because of some mistake or fear. Or it may be somewhat of a tactic to impress on the other side the readiness of the trial team. Or it may simply be that the two skills are difficult to find in one person. Regardless, those that do possess both skills, and there are many, have the advantage of bringing the full picture to the negotiating table and thereby giving the client professional judgment based upon the subtleties presented in each situation. However, the more this specialization takes place, the less frequently these attributes will be combined in one person.
